



RELAI SWEEPSTAKE - OFFICIAL RULES

PARTICIPATION IS LIMITED TO LEGAL RESIDENTS OF SWITZERLAND AND ITALY.

VOID WHERE PROHIBITED.

THIS SWEEPSTAKE SHALL BE CONSTRUED ACCORDING TO AND GOVERNED EXCLUSIVELY BY SWISS LAW.

1. Contest Description: This promotional contest (the "**Sweepstakes**") is organized to engage participants in predicting the future price of Bitcoin.

2. Eligibility: The Sweepstake is open to individuals who:

- Are at least 18 years of age or older and the legal age of majority in their jurisdiction of residence;
- Have completed identity verification (KYC) and hold a verified Relai account in good standing;
- Are residents of countries where Relai is authorized to conduct marketing activities (**currently Switzerland and Italy**).

The Sweepstake is not open to employees, officers, directors, or immediate family members (spouse, partner, parent, legal guardian, in-law, grandparent, child, or grandchild) of Relai AG, a company organized and existing under the laws of Switzerland, under company registration number CHE-340.229.036 whose registered office is located c/o Westhive AG, Hardturmstrasse 161, 8005 Zurich Switzerland (the "**Sponsor**"), or its affiliates, subsidiaries, promotional agencies, or anyone living in the same household of such individuals (whether related or not). The Sweepstake is subject to federal, state, and local laws and regulations. **Void where prohibited.** Participation constitutes the entrant's full and unconditional agreement to these Official Rules and the Sponsor's decisions, which are final and binding in all matters related to the Sweepstake. Winning a prize is contingent upon fulfilling all requirements set forth herein.

3. Timing: The Sweepstake begins on **May 1, 2025 at 00:00 CET** and ends on **May 31, 2025 at 23:59 CET** (the "**Sweepstake Period**").

4. How to Enter: Participants will be automatically entered into the Sweepstake by purchasing at least **€1,000 worth of bitcoin** during the Sweepstake Period (May 1–31, 2025) using the Relai app. This includes both one-time bitcoin purchases and savings plan transactions. Only one entry per participant is allowed. **ALL POTENTIAL WINNERS ARE SUBJECT TO VERIFICATION BY THE SPONSOR, WHOSE DECISIONS ARE FINAL AND**

BINDING. A participant is not a winner of any prize unless and until their eligibility and compliance with all requirements have been verified and the participant has been officially notified. Participants must comply with these Official Rules. Determination of compliance will be at the sole discretion of the Sponsor. **Limit:** One entry per person/Relai account/email address. Creating additional accounts or canceling and recreating accounts during the Sweepstake Period to gain more entries will result in disqualification. Any attempt to use multiple accounts, emails, or automated systems to participate is strictly prohibited and will void all associated entries. In the event of a dispute regarding the identity of a potential winner, the authorized account holder of the email address linked to the verified Relai account will be deemed the entrant. The potential winner may be required to provide proof that they are the authorized account holder. The “authorized account holder” is the natural person assigned to that email address.

5. Winner Notification: Winners will be randomly selected from eligible participants by an internal manual process after the Sweepstake Period ends. Winners will be contacted directly by Relai Support via their registered account details. Bitcoin prizes will be credited directly to their Relai wallets. Winners do not need to take further action to claim their prize. There will be **no public announcement of the winners.**

6. Prize Details: Prizes will be awarded as follows:

- 🏆 **1st Prize:** €5,000 in bitcoin
- 🥈 **2nd Prize:** €2,000 in bitcoin
- 🥉 **3rd Prize (x3 winners):** €1,000 in bitcoin each

All Prizes will be **credited directly to the winners' Relai wallets.** The bitcoin amount for each prize will be calculated **at the time of disbursement,** using the **market price available on the Relai app** at that moment. The disbursement will occur **within 2 business days from the date winners are confirmed and verified.** Prizes are non-transferable. No cash alternatives or substitutions will be made, except at the sole discretion of Relai AG.

7. Taxes: Each winner is solely responsible for reporting and paying any applicable taxes related to the prize(s). Each winner will be subject to an onboarding verification process and must provide any requested tax reporting information before any prize is awarded, including name, date of birth, address, phone number, social security number, or taxpayer identification number. The value of any prize awarded to a winner will be reported for tax purposes as required by law. The winner should consult an accountant or tax professional to determine tax implications in accepting and using (including conducting transactions of) any Prize.

8. Release: Entrants/winners agree to release, discharge, and hold harmless Released Parties from and against any claim or cause of action or liability (including but not limited to personal

injury, death, or damage to or loss of property as well as claims based on publicity rights, defamation and/or invasion of privacy) arising out of or in connection with participation in the Relai Contest or acceptance/receipt/use or misuse of any prize, and agree to be bound by the Official Rules and the decisions of the Sponsor, the Sponsor's representatives, which are final.

General: ANY ATTEMPT BY AN INDIVIDUAL TO DELIBERATELY UNDERMINE THE LEGITIMATE OPERATION OF THIS PROMOTION IS A VIOLATION OF CRIMINAL AND CIVIL LAWS, AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH INDIVIDUAL TO THE FULLEST EXTENT PERMITTED BY LAW. Sponsor will not be responsible for lost, late, damaged, misdirected or mutilated mail, misdirected email, or for any technical problems, faulty, lost, garbled, incomplete, incorrect or mistranscribed data transmissions, incorrect announcements of any kind, malfunctions, technical hardware or software failures of any kind including any injury or damage to any person's computer/mobile device related to or resulting from participating in or experiencing any materials in connection with this Sweepstakes. Sponsor is not responsible for malfunctions or breakdown of any network systems, unavailable service connections, lost, incomplete, faulty network connectivity of any kind, failures of any service providers, or any combination thereof, which may limit a person's ability to participate in this Promotion. Sponsor reserves the right to suspend, cancel, or modify the Promotion if it cannot be executed as planned for any reason including, but not limited to, if fraud, human error, technical failures, or any other factor impairs the integrity or proper functioning of the Promotion; or if a virus, bug or other technical problem corrupts the administration, security, or proper play of the Promotion as determined by Sponsor in its sole discretion. If the Promotion is so canceled or modified, Sponsor may award prizes from among all eligible participants before such action, and Sponsor shall have no further obligation to any participant in connection with this Promotion. Sponsor reserves the right to prohibit an individual's participation if fraud or tampering is suspected or if the participant fails to comply with any participation requirement as stated herein or with any provision in these Official Rules. If there is a discrepancy or inconsistency between disclosures or other statements contained in promotional materials and the terms and conditions of the Official Rules, the Official Rules shall prevail, govern, and control. The sponsor will not be responsible for any typographical or other error in printing the offer, administering the Relai Contest, or announcing the prizes.

10. Disputes: All state and local laws and regulations apply. THE SWISS COURTS (STATE AND FEDERAL) SHALL HAVE SOLE JURISDICTION OVER ANY CONTROVERSIES REGARDING THE PROMOTION, AND THE LAWS OF THE STATE OF SWITZERLAND SHALL GOVERN THE PROMOTION. EACH ENTRANT WAIVES ANY AND ALL OBJECTIONS TO JURISDICTION AND VENUE IN THOSE COURTS FOR ANY REASON AND HEREBY SUBMITS TO THE JURISDICTION OF THOSE COURTS. Claims may not be resolved through any form of class action. By entering and participating in the Promotion, Entrants hereby expressly agree and accept that for all that is related to the interpretation, performance, and enforcement of these Official Rules, each of them expressly submit themselves to the laws of Switzerland, waiving to any other jurisdiction that could correspond to them by their present or future domicile or by any other cause.
